Description of Network Change:

ZiPLY Fiber announces that it that it intends to retire copper facilities serving in the following wire center located in the state of Oregon

4 PGE poles along Halsey Loop Rd. are being removed due to a development project involving road improvements. As a result of this project, ZiPLY Fiber intends to retire copper facilities and deploy a fiber network infrastructure to serve all existing and future customers. All copper facilities currently in place will be retired and removed from the records. Implementation to begin within 30 days of being deemed final pursuant to the FCC notice.

Description of Reasonably Foreseeable Impact of the Changes:

For the 5 working locations reflected in **Attachment A**, ZiPLY Fiber will (1) no longer offer services over copper facilities; and (2) cease maintaining the copper facilities. Of the 5 presently working locations impacted by this change, all are competitive carrier circuits. ZiPLY Fiber's Account team will be contacting the impacted CLEC partner to discuss disposition.
