Subject: Public Notice of Copper Retirement Under Rule 51.333

Implementation Date: Upon being deemed final pursuant to FCC Notice with the project targeted to

begin on or after August 15, 2023.

#### **Description of Network Change:**

**Ziply Fiber** announces that it intends to retire copper facilities serving the following wire center located in the state of Oregon.

Wire Center: GRESHAM, OR Address: 150 NW 20TH ST CLLI: GRHMORXB

The specific serving locations are listed in **Attachment A**. Due to an Oregon Department of Transportation right-of-way improvement project, Ziply Fiber is required to remove and relocate its facilities and equipment located within the boundaries of the project area, impacting serving locations shown in Attachment A. Ziply Fiber plans to deploy a fiber network infrastructure to serve all existing and future customers. Existing customers on copper facilities will be migrated to the new fiber network infrastructure without incident. All copper facilities to be retired and removed from the records.

#### **Description of Reasonably Foreseeable Impact of the Changes:**

For the locations reflected in **Attachment A**, Ziply Fiber will (1) no longer offer services over copper facilities; and (2) cease maintaining the copper facilities. There are presently 15 customers with impacted services, none of which is a competitive carrier circuit.
